My loved one was living on a reserve and has died. Who can help me with their estate?

If your loved one was living on a reserve and has died, Indigenous Services Canada (ISC) and Crown-Indigenous Relations and Northern Affairs Canada (CIRNAC) are responsible for helping you with their estate.

Under the *Indian Act*, ISC and CIRNAC are only involved with the estates of deceased First Nations individuals who usually lived on a reserve when they died. This includes someone who may have temporarily lived off-reserve prior to death for education purposes or to obtain health care or services not available on a reserve.

ISC is responsible for estate services in all provinces. CIRNAC is responsible for estate services in the Yukon and Northwest Territories.

My loved one was living off-reserve and has died. Who can help me with their estate?

If a First Nations person was living off-reserve when they died, the estate is the responsibility of the province, territory or country where they lived.

You will need to contact the appropriate provincial or territorial government office for information on the next steps.

How can Estate Services help me with the estate process?

Estate Services helps by

- Providing general information about estate services
- Providing estate forms
- Accepting documents, such as the proof of death and completed forms
- Obtaining contact information for the next of kin of the deceased
- Referring your information and documents to the regional offices so they can appoint an administrator for the estate

How can the Public Enquiries Contact Centre help me with the estate process?

Generally, the Public Enquiries Contact Centre provides information about:

- Indian status applications and cards, as well as Temporary Confirmation of Registration Documents
- ISC and CIRNAC's programs and services
- free publications related to programs and services
- requests for statistical information

When you contact the Public Enquiries Contact Centre regarding an estate, they may ask questions to confirm the identity of the deceased and obtain your general contact information.

Public Enquiries will then refer your request to Estate Services or to a regional office, depending on what you need, and they will follow up with you.

How can the regional offices at ISC or CIRNAC help me with the estate process?

Regional estates staff perform many duties, some of which are:

- approving wills
- appointing executors and administrators for estates
- administering the estate as a last resort if the family or friends of the deceased are unavailable to administer

The regional office that will be responsible for the estate depends on the province or territory where the individual died. For example, if a member of an Alberta First Nation lived on a reserve in British Columbia and passed away there, the regional office in British Columbia will help with the estate.

My loved one was living on a reserve and has died. How do I begin the estate process?

To begin the estate process, provide the following information to ISC or CIRNAC:

- The full name, date of birth, date of death and 10 digit registration (Indian status) number of the deceased
- Proof of death document, such as: a vital statistics death record or extract; church death certificate; coroner's report or burial permit or internment certificate
- Where the deceased lived at the time of death – on or off-reserve
- Names and contact information for the family of the deceased – mailing addresses, email addresses, and phone numbers
- Whether the deceased had a will – if there was a will, the original will need to be provided to the appropriate regional office for approval along with a completed application for approval of will form.

Does ISC or CIRNAC charge a fee to appoint an administrator or executor for an estate?

No, ISC or CIRNAC do not charge a fee to appoint administrators or executors of estates.

By regular mail to the ISC or CIRNAC regional office in the province where the person died. The addresses for the regional offices are included at the end of this document.

Some estate forms need to be signed by a Commissioner for Oaths. Where can I find one who can witness and sign my forms?

If you need documents or forms to be notarized or commissioned, check online, in the Yellow Pages, or consult with your local library on how to locate a notary or commissioner in your community.

I need a Commissioner of Oaths for the Appointment of Administrator application form.

I do not have access to a service to have this completed OR I live in a remote community and it is almost impossible to have this completed. How can I get this completed?

When the commissioning of oaths is not possible, application forms may be accepted without being commissioned subject to the following:

- When an application form is not commissioned, an individual over the age of majority (according to your province/territory) should witness the applicant's signature, include their name as witness, and sign the application along with the applicant.
- Include a statement with the application that indicates that the document has not been commissioned due to the established COVID-19 pandemic measures currently in place in the province/territory.
